GAF Summary of Activities

The Geneva Agape Foundation (GAF) was founded in Geneva on 10 March 2014 and registered on 25 September 2014. Whereas 2015 was a year of institution building and support of first projects of Globethics.net, 2016 was the first year of operation, opening of office and employment of staff.

- Board: The Founder of GAF, Prof. Dr Cui Wantian, was elected as President of the Board of Foundation as of 1 Aug 2016. The three other Board members remained the same (see page 7). Three Board meetings in Geneva and China have been held.
- **Staff:** The former President Prof. Dr Christoph Stückelberger was ap-

pointed as Executive Director and Vice-president, also as of 1 Aug 2016, Ms. Joy Cadangen as Programme and Finance Officer and Ms. Vanessa Wang as Project and Communication Officer (see page 7) as staff in the Geneva Office

Strategy and Programmes 2017-2020: The Board approved the strategy 2017-2020. The GAF motto "Innovate, care, invest by values-driven entrepreneurship" expresses a clear focus on the target group of entrepreneurs and their contribution to society by values-driven companies, caring by philanthropy and ethical investments (see page 4-5 on three programmes.

- Partners: The most important partnership agreements have been signed with the new Liaoning Agape Foundation LAF in the Liaoning province in North East China and with the famous Amity Foundation in Nanjing, whose international Geneva Office is hosted by GAF.
- Finance: GAF received income of CHF 403'363.00 and had expenses of CHF 403'030.00, ending with a small surplus of CHF 302.00.

GAF Programmes

Programme 1 Values-driven Entrepreneurship





GAF supported ethics trainings of Entrepreneurs in China.

GAF published with Globethics Publications a book on values-driven entrepreneurship with twelve training modules.

In a one-week training for 30 Chinese entrepreneurs in Kenya established relations with African entrepreneurs, churches and universities. GAF supported also online collection of ethical training materials on the Globethics.net online library.

Programme 2 Caring Philanthropy



GAF supported with know-how the creation and registration of the Liaoning Agape Foundation LAF in the Liaoning Province in North East China. LAF successfully started the project "Angels with Broken Wings" for marginalised or left-alone children and young people. GAF also gave philanthropy training for 120 entrepreneurs and pastors.

Programme 3 Ethical Investments



GAF prepared two books on philanthropy published in early 2017. In addition, GAF signed a partnership agreement with the famous Amity Foundation in Nanjing/China, the 30 years old and one of the largest Chinese foundations for social services, emergency aid, education and projects with disabled persons.



GAF started to develop criteria for values-driven investments and venture philanthropy, together with investment funds in China and Switzerland. This programme is at the beginning.
